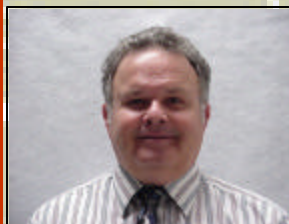

Field Manager Focuses On Occupational Licenses

In an effort to assist all businesses throughout Polk County in meeting their county occupational license tax requirements, the Tax Collector's Office has recently reorganized its Delinquency and Enforcement Department.

Field Deputy Manager, Wade Whiddon, the agency's senior Field Deputy, will now focus almost exclusively on field operations involving businesses and assisting them with their occupational

license tax responsibilities.



Whiddon has served in the Tax Collector's Office since 1977. His knowledge and familiarity with local business

taxes will be useful to all classes of business owners, including vacation home owners and managers. Occupational licenses are required for any individual, partnership or corporation,

Occupational license tax revenues are generally distributed to the Polk County Board of County Commissioners (BOCC) and are primarily used to fund economic development activities in Polk County.

TDA 2007 Seal of Compliance Request for Applications Announced



The Tax Collector's Office announces that it is accepting applications now for the **2007 SEAL OF COMPLIANCE.**

The **SEAL OF COMPLIANCE** is a designation earned by management companies that represent one or more tourist development tax accounts on file with the Polk County Tax Collector's Office and who have met or exceeded the industry specific criteria established relating to local tax compliance. Participation in the program is voluntary. This is the first issuance of the "SOC" certificates, which will be issued annually on January 1 of each year. All participants in the "SOC" program must apply to the Tax Collector's Office at least 30 days prior to the issuance of the annual certificates. (*Applications are available online*)

Applicants who submitted a completed application by June 1 were eligible to receive a 2006 "SOC" Certificate and

will automatically qualify for the 2007 "SOC" Certificate. Participants applying after June 1, 2006 and before December 1, 2006, will be eligible for a 2007 "SOC" Certificate.

SOC recipients will receive: a Letter of Commendation, a Certificate of Award, table tents for display in rental units, and a listing on the Tax Collector's website, among other benefits.
